

LAST WILL AND TESTAMENT

OF FEDOR ARTEMEIVITCH TERESTCHEKO

In the name of the Father, the Son, and the Holy Spirit. Amen! Made in this year eighteen hundred and ninety-three, on the twentieth day of March. I, the current, State Councilor, Fedor Artemievitch Tereshchenko, with all my faculties and all my memory, have decided to make the present will whose contents follow. In order to avoid any misunderstanding and to guarantee precise and accurate execution of my following instructions contained in this will, I find it necessary to explain, above all, that all my property and real estate business benefit from a double entry accounting in force and an annual audit. I have instituted in this way local economic and factory offices, and a main office in Kiev that concentrates all the reports of the local offices. All sums collected from properties, factories and third parties are headed by the Kiev Local Office.

For the 1st of March of each year, all accounts are verified, and an annual general balance sheet is made, and on 1 March of each year a new accounting year begins. I instruct the executors and guardians appointed by me to keep this order after my death.

Secondly, I do not find it pointless to point out that among my real estate properties located in the provinces of Volyn, Kiev and Kursk, I have instituted two forbidden Tchervonsky and Martinovsky properties. The first, after my death, after the constitution, will become the property of my son Fedor Tereshchenko, and the second, that of my daughter Nadezhda Tereshchenko.

In view of the borderless love I have for my dear children and my kind wife Nadezhda Vladimirovna Tereshchenko, in wanting to offer each of them a fair share of my property and wishing to preserve for the future the activity to prosper in my property, my sugar factories (from sugar beets) and distilleries, I find it necessary to give the recommendations below that must be followed to the letter after my death.

1. I am bequeathing my son Fedor Tereshchenko, as owner:

- a) All the material, all the assets, furniture, provisions, works and materials that appears, have in the accounts of the accounting books of each property and each factory that is part of the forbidden property of Tchervonsky, on the date of March 1st of the current accounting year, the year or this property, after the constitution, will become the property of my son Fedor Tereshchenko. Among the provisions in this point I exclude only white sugar and alcohol which, on the day of my death, may be part of the production of the accounting year N-1, since this white sugar and alcohol must be invested and attached to the capital of which is discussed in paragraph IX of this spiritual testament. The sugar deductible for this year N-1 must be paid with this capital.
- b) All sums of money from the forbidden property of Tchervonsky which during the accounting year until the day of my death will be cashed by my Kiev Local Office, for provisions, works and other objects of this year's accounting in progress.
- c) Four hundred thousand rubles of working capital. Since I am leaving this capital to my son, Fedor Tereshchenko, as working capital, the sum of these four hundred thousand rubles in money must include: all the sums that on the day of my death since March 1 of the current accounting year will be paid by the Local Bureau Kiev and by my other local offices, third parties and different institutions derived from the forbidden property of Tchervonsky and all the sums delivered by these offices at the local offices of the forbidden property of Tchervonsky in cash, goods, materials of different nature and other sources

- d) The real estate in Volyn provinces, Zhitomyr district, in the village of Nikonovka, which I acquired from the noble Yuzefa Penkovska
- e) Part of the property called "the farm" Elenovka" is located in Volyn province, Zhitomyr district, in the villages Kirilovka and Neforoshch that I acquired from Vassily Orlovsky and which (this part) is not part of the forbidden property of Tchervonsky
- f) The property in Kursk province, Count Poutivlsky, in the village of Karpilovka which I acquired from Evpraksia Makovneva
- g) A stone house at No. 3 Alekseevskaya Street in Kiev with annexes and land, all furniture and a gallery of paintings
- h) A stud farm located in Krasovka as part of the forbidden property of Tchervonsky
- i) All the tools, all the furniture of any kind, works and materials from the properties indicated in the points d, e, f, and h of this paragraph and which will be in the reports of the books on March 1 of the current accounting year and that will be the one of my death.

2. I am bequeathing to my daughter Nadezhda Tereshchenko, as owner:

- a) All tools, all furniture of any kind, works and materials from every property and sugar factory that is part of the banned Martynovskoe property that will appear in the accounts of each factory that is part of the forbidden property of Martynovsky, has the date of march 1 of the current accounting year, the year that property, according to the constitution, will become the property of my daughter Nadezhda Tereshchenko. Among the provisions in this point I exclude only white sugar and alcohol which, on the day of my death, may be part of the production of the accounting year N-1, since this white sugar and alcohol must be invested and attached to the capital of which ii is discussed in paragraph IX of this spiritual testament. The sugar deductible for this year N-1 must be paid with this capital.
- b) All sums of money from Martynovsky's forbidden property which during the accounting year until the day of my death will be cashed by my Kiev Local Office, for provisions, works and other objects of that same year.
- c) Two hundred and fifty thousand rubles in silver, in working capital. Since I am leaving to my daughter Nadezhda Tereshchenko this capital as working capital, the sum of these two hundred and fifty thousand rubles in cash must include: all the sums that at least exist on the day of my death since the 1st of March of the current accounting year will be paid by the Kiev Local Office and by my other local offices, third parties and institutions different from the forbidden property of Martynovsky and all the sums delivered by these same offices to the local offices of the forbidden property of Tchervonsky in cash, goods, materials of different nature and other sources.

- d) Real estate located in Kiev province, Kiev district, in the village of Malaya Olshanka including the hamlet Deriamezianka and part of the village of Kopacheva
- e) The real estate in Kursk province, Poutivlsky district, in the village Leontievsky
- f) All the tools, all the furniture of any kind, works and materials from the properties indicated in the points d and e of this paragraph and which will be in the minutes of the accounting books as of 1 March of the current accounting year and which will be in said accounts on that death of my death.

III. If I can't pay my debt to the bank in my lifetime for the property Leontievsky, in Kursk province, Poutivlsky district, then this debt must be paid with the capital remaining in the one year from the day I died.

IV. I bequeath to my daughter Natalia Tereshchenko the following property:

- a) The real estate located in Podolsk province, Olgopolsky district, in the village Miastkovka in the hamlet Marianovka
- b) The real estate located in Kursk Province, Kursk, Berdichevsky District, of Nepedovka village
- c) I wish to unite the two aforementioned properties, Miastkovka with the hamlet Marianovka and Nepedovka,, in one forbidden property, always for the benefit of my daughter Natalia Tereshchenko and I take care to make steps in this direction. However, if this property should not be established before my death, I ask the executors of this will to take care of it as it should be.
- (d) The Real Estate in Volyn Province, Count Novogrod-Volynski district, in the Rytov village, including the hamlet Marysin
- e) The real estate in these same provinces and districts in the village Goropan
- f) The real estate located in these same provinces and districts in the village Gordievka
- g) The real estate in these same provinces and districts, in the village Milentsakh, or Nastin or Stepok Farm
- h) Real estate in these same provinces and districts, in the village Kamen
- i) Real estate in Volyn province, District of Zhitomyr, named "Yuzefovka Farm"
- j) The real estate in these same provinces and districts in the village Krasnovoulka Krasnogoulka
- k) The real estate in Volyn province, District of Zhitomyr, in the village Podoliansakh
- l) The real estate in these same provinces and districts, in a forest of the name "Ogorozhennyi", near the hamlet Marotchenky
- (m) All the assets, tools, all the personal goods of any kind, works and materials materials from the properties indicated in points a, b, d, e, f, h, i, j, k and l of this paragraph and which will be in the accounting books' reports on 1 March of the current accounting year and which will be in the same of 1 March in the year of my death.
